

## IN THE NEWS

**Locked-up children left 'extremely cold' at Baltimore facility, public defenders say.**  
The attorneys also said the incarcerated children are "spending almost all hours of the day in cramped cells deprived of school and physical activity" and that facility leadership has indicated that they anticipate receiving parts needed to fix the heating system early next week. The conditions have already "been going on for over a week," they said. "This is unconscionable," Public Defender Natasha Dartigue said in her office's statement. "Baltimore City Public Schools closes when indoor temperatures are this low because we recognize that children cannot learn, cannot thrive, cannot be safe in those conditions." Acting Maryland DJS secretary highlights efforts taken to drop juvenile crime numbers. Betsy Fox Tolentino, the acting secretary of Maryland's Department of Juvenile Services (DJS), says juvenile crime is down despite residents saying they still feel unsafe and more needs to be done to address the violence. "We're seeing that when we hold people accountable, and we have the right level of community support, we can really see a drop

in violent crime," Fox Tolentino said. Check out [this CBS News article](#) for more details.

**Recent report sheds light on incarcerated who committed crimes as kids.** A recent report by Human Rights For Kids (HRFK) offers insight into the lives of incarcerated individuals who committed crimes as children. **Juvenile justice commission wants to stop automatically charging youth as adults.**

"This practice fails to protect communities. Instead, it disproportionately impacts children of color, diverts resources away from critical services for children and families, places children in dangerous environments that more often result in subsequent violent or general criminal behavior," says the report, which was approved by the commission. "The problem is not one of minor procedural adjustments; it is structural." Read the report [here](#) and find the Maryland Matters summary [here](#).

**Maryland prosecutors push back on plan to end automatic adult charges for youth offenders.** While the Commission on Juvenile Justice Reform and Emerging and Best Practices argues the policy fails to improve public safety and instead harms young people, many of the states top prosecutors said they strongly disagree. **North Baltimore residents won their fight against a locked treatment facility for youths.** The state is ending plans to bring a youth detention center to North Baltimore, to the relief of neighbors who had strongly opposed its placement in a residential area. **Bates to cut ties with mayor's public safety office, citing 'cloak of secrecy'.** Tracy King, a spokeswoman for Mayor Brandon Scott, said the mayor is "significantly distressed by this absurd approach." In the first paragraph of Bates' 7-page letter sent to the mayor, Bates said Scott rebuffed several requests to meet to discuss his concerns about MONSE. Emails obtained by [the Baltimore Banner](#) via a public information request show MONSE's director Stefanie Mavronis repeatedly attempted to meet with Bates and his staff in July and August without success.
